BYLAW NO. 4835

A Bylaw to amend the "Boulevard Frontage Tax Bylaw, 1982"

The Municipal Council of The Corporation of the District of Oak Bay, in open meeting assembled, enacts that Bylaw No. 3416, being the "Boulevard Frontage Tax Bylaw, 1982", as amended, is further amended as follows:
