To ensure adequate delivery time, the last day a mail ballot package will be mailed out is **October 6th. The last** day to request a mail ballot package to be mailed out is **Wednesday**, **October 5**.

The last day to request a mail ballot package for pick-up is noon on Friday, October 14. We would appreciate as much lead time as possible to prepare your package; it is not possible to request a package for immediate pick up.

Mail ballots may be picked up from Municipal Hall until 4:30 p.m. on Friday, October 14.

On General Voting Day, you may hand deliver your mail ballot to any of the official polling stations between 8:00am and 8:00pm.

You are responsible for ensuring that your completed ballot is received by the Chief Election Officer no later than 8:00 p.m. on General Voting Day, Saturday, October 15, 2022.

Personal information in this form is collected for the purposes of administering your mail ballot and to provide you with relevant information and notifications from the District of Oak Bay regarding your mail ballot. The District of Oak Bay is collecting this information under s.26(b) and s.26(c) of the Freedom of Information and Protection of Privacy Act (FOIPPA).
