RESPONSIBILITIES

- Coordinates, plans, assigns, and maintains a daily schedule of activities for Licensed Care, Before and After School Care programs and camps.
- Provides leadership, guidance, and gives daily work direction to staff.
- Ability to organize and prioritize workload, while working under pressure with general supervision to meet deadlines.
- Hires, trains, schedules, supervises, and evaluates auxiliary staff to meet program goals and objectives.
- Communicates with families, children, and staff on a variety of issues and program initiatives.
- Ability to be Licensing Manager to meet Island Health Licensing Regulations, and ensures guidelines are adhered to.
- Attends meetings with community partners and inter-municipal working groups within Greater Victoria area.
- Coordinates program set-ups and equipment with supply ordering, purchasing, and distribution.
- Ability to work a variety of shifts to meet operational needs and requirements of the program.
- Performs other program related duties as required.

- Graduation from a two-year post-secondary program in Recreation, or a related field.
- Minimum of one year experience in Community Recreation programming.
- Direct experience working with children in a recreational setting.
- Excellent interpersonal, customer service, and problem-solving skills.
