Mayor Causton called the meeting to order at 7:30 p.m.

COMMUNICATIONS:

1. 2010-275 DIRECTOR OF PARKS AND RECREATION, October 20, 2010 Re Neighbourhood Learning Centre Barbeque

(Lorna Curtis, Director of Parks and Recreation, in attendance for this item.)

Councillor Cassidy declared a conflict of interest with respect to the first two items on the agenda (correspondence items no. 2010-275 and 2010-276), noting that his firm is engaged by School District No. 61. Councillor Cassidy left the meeting at 7:33 p.m.

Lorna Curtis advised that following the Neighbourhood Learning Centre open houses, and in preparation for the Project Definition Report being submitted to the Ministry of Education, there will be a campaign to inform as many community members as possible of the proposed project. To assist with this objective, Ms. Curtis said that Recreation Oak Bay staff would like

to host a community barbeque on the front lawn of the Municipal Hall on November 6, 2010, and invited Council members to participate in the event.

It was noted that in the event of inclement weather, staff would like to set up the displays and banner in the Municipal Hall foyer.

Seconded by Councillor Jensen, That permission be given to Recreation Oak Bay to conduct a community barbeque on the front lawn of the Oak Bay Municipal Hall, (including use of the Municipal Hall Foyer for displays if required) from 12:30 o'clock p.m. to 2:30 o'clock p.m. on Saturday, November 6, 2010, to raise community awareness of the proposed Neighbourhood Learning Centre.

2. 2010-276 GREATER VICTORIA SCHOOL DISTRICT, October 21, 2010

Re Request for Funding – Oak Bay High School / Community Theatre
and Arts Facilities

(Tom Ferris, Board Member (Chair), Michael McEvoy, Board Member, George Ambeault, Secretary-Treasure, Seamus Howley, Director of Facilities, Greater Victoria School District, and Dave Thomson, Principal, Oak Bay High School, in attendance for this item.)

<u>Dave Thomson</u>, Principal, Oak Bay High School, drew attention to the Greater Victoria School District Board of Education's request for funding to go towards enhancing the theatre and arts facilities for the new Oak Bay High School.

Mr. Thomson noted that the provincial funding for high schools does not provide for the inclusion of a theatre, therefore, the Board would be short \$1,400,000 of its goal to complete the community theatre. Although they feel that \$400,000 can be raised, said Mr. Thomson, the Board is requesting that the District of Oak Bay contribute the remainder of the funds for the theatre project in two parts; \$500,000 in the fall of 2011 and \$500,000 later in 2013.

Attention was draw to the Canadian College of Performing Arts possible interest in using the proposed theatre for their programs, and it was determined that the space would likely not meet the theatre group's requirements and the provision of adequate parking for its use would be an issue.

<u>Michael McEvoy</u>, School Board member, took this opportunity to thank Council and municipal staff for their collaborative efforts in working together with the School District in seeing the project continue to move forward.

There was further discussion regarding the proposed project and request for funding, and various questions from Council members were answered by the School District representatives in that regard. The benefit the theatre and arts facilities could contribute to the community was acknowledged by members of Council, and there was consensus that funding should be supported in principle.

MOVED by Councillor Herbert

Seconded by Councillor Copley, That staff be directed to provide a letter to the Greater Victoria School District indicating Council's support in principle, subject to budgetary approval and subject to the Municipality arriving at an appropriate and satisfactory method of financing, for

the requested funding contribution of \$1,000,000 towards the Community Theatre and arts facilities for the new Oak Bay High School.

Acknowledging that the proposed resolution only provides support in principle for the funding request, and in response to the question of whether that would be sufficient for the Province, <u>George Ambeault</u>, Secretary-Treasurer, Greater Victoria School District, advised that the Province requires that funding be in place before final approval of the project by the Province. Therefore approval of municipal funding would be needed by March 2011 at the latest.

The Municipal Administrator confirmed that Council cannot commit to the funding at this time, however, it could be introduced into the financial plan for 2011 and 2012 for consideration.

As to how the funds could be raised, the Municipal Treasurer provided information on possible options to be looked at further when the financial plan is considered later in the year.

The question was then called.
